## **County Commissioner Pct. 4**

# **District Attorney**

The Kleberg and Kenedy County District Attorney's Office is reinstituting COVID protective measures.

At this time, we will have the Office doors locked. If you wish to have a face to face meeting with our investigator or any member of our staff, I would respectfully request that you call the office first and make an appointment (361-595-8544 / 8545). We can then meet either in the 105<sup>th</sup> District Courtroom (with Judge Pulcher's continuing approval) and/or the Grand Jury room. This will minimize the exposure of my staff and will allow us to sanitize / clean the area before and after. I would also ask that anyone meeting in person with my staff wear a protective mask if possible.

We will continue to operate on Zoom and will work to find additional ways to conduct business with a minimum of disruption.

# **Kleberg County Juvenile Probation**

The Kleberg/Kenedy County Juvenile Probation Department in reference to the Covid Epidemic is following the CDC Guidelines for the safety of the community, our children and our employees. Our department's protocol is that all employees and clients before entering our building, are provided with a temperature check, clients are to wear face masks before entering our building. Hand sanitizer is provided by our department and safe distancing is required. Our employees during our sessions with our clients are to wear face masks, safety gloves and provide safe distancing. Our hours of operation are from Monday through Thursday 7:00 a.m. to 6:00 p.m. Our work consists of office visits and daily and weekly telephone calls to keep in contact with our clients and also provide home visits through social distancing. All safety methods are being provided by our department by the CDC to keep our employees, clients and the community safe from this pandemic.

### **COVID-19 Operations Plan**

This CSCD is committed to providing our services, although some limited, to our offender population, the Courts, and the Community following CDC guidelines along with government mandates.

### OFFICE HOURS/CONTACT INFORMATION AND RULES

- Monday through Friday from 8:00 a.m. 12 noon & 1:00 p.m. 5 p.m.
- Main Office Telephone Number 361-595-8558
- Defendants/Visitors allowed in lobby and classroom areas only.
- Defendants allowed to be accompanied only by their attorneys into the building.
- Must follow 6 feet social distancing upon entering the building.
- Hand sanitizer available upon entering the building
- Temperature taken by CSCD employee with non-contact infrared body thermometer if visitor displays symptoms or informs staff of COVID related symptoms.
- Visitor/Employee mask use encouraged, but not mandatory. Mask will be provided, if necessary.

### SUPERVISION OF OFFENDERS

- In response to COVID-19 emergency procedures, TDCJ-CJAD has temporarily modified "Direct" supervision requirements to allow for telephone contact/supervision of offenders until August 31, 2021. Telephone/Office contacts conducted on appointment basis.
- Sex Offender home checks/field visits continue to be conducted following social distancing and other safety measures. "Other" field visits conducted on as needed/emergency basis.
- Jail visits conducted according to Jail COVID procedures. Jail staff works closely with CSCD staff in arranging Zoom/telephone meetings.
- Education classes (DWI Ed., Drug Offender Ed., DWI Repeat Offender) currently offered, but limited. Social distancing/sanitary practices utilized.
- Limited number of Community Service workers allowed to perform hours at one given time. Worker must follow social distancing, and take temperature upon entering employee-only section of building. Mask provided if requested.
- Drug tests are being conducted under specific request/order of the Courts, CSO, etc.
- Provide Court services via Zoom or in person depending on court requirements.

# **SANITATION**

- CSR workers/CSCD staff are sanitizing all public areas of building (door knobs, water fountain, restrooms, counters, tables, chairs, etc.) throughout the day.
- CSCD employees are sanitizing their own work area throughout the day.
